Throughout his career, Afzal has had the honour of serving as a Senior Manager and Lead Age Assessor, providing him with numerous opportunities to contribute to national agendas and influence policymaking. As a practitioner, Afzal is dedicated to ensuring that confidential, professional support and advice are always accessible to individuals in need of social care assistance.

Afzal has experience in conducting assessments of foster carers and kinship carers – Afzal has carried out assessments both in the UK and abroad, with the most recent being in 2011.

Afzal has extensive experience in conducting complex direct work with children, including assessing their needs and risks. In addition to engaging in complex safeguarding and child protection cases, court proceedings, and work with children in care and care leavers.

Social Work Career:

Afzal qualified as a social worker in 1996, having previously worked as a project manager in a large transportation company.

Afzal has current knowledge of proposed and existing legislation, statutory regulations, government guidance, and standards related to children and fostering. Afzal is familiar with child protection, looked-after children, foster carers, and issues affecting looked-after children. Afzal understands social work theories and values, including research and how to apply them in practice using the most recent and relevant evidence. Additionally, Afzal has a working understanding of attachment theory-based practice and is aware of the mental health needs of children and adolescents.

Afzal possesses skills in assessment and report writing. Afzal has prepared care plans, pathway plans, and court statements. Afzal has extensive experience conducting Merton complaint Age Assessments as well as Human Rights Assessments for various local authorities in London and outer London.

Afzal has conducted high-quality, comprehensive assessments of children and families using the assessment framework to plan, support them in implementing those plans, and review and reassess needs following practice standards. Afzal has worked in various authorities within and outside London since 2004. Afzal initially worked as an independent social worker, progressing from a manager and group manager to his current role as a service manager.

As a social worker, Afzal was responsible for high-risk and complex cases, including young people undergoing mental health assessments. As a manager, Afzal supervised child-care social work staff—planning, allocating, and reviewing the work of the team and individual members, while setting and monitoring practice and performance standards.

As a group/service manager, Afzal took on a joint leadership role in developing and overseeing the strategic policy for young people leaving care. Afzal ensured that operational services for young people leaving care adhered to statutory regulations and guidance. Afzal manages child-care social work staff by planning, allocating, and reviewing the work of units and individual team members, as well as setting and monitoring standards. Afzal was also a Fostering Panel Advisor during the service's reorganisation. Afzal provided effective leadership for the service, taking responsibility, remaining accountable, and motivating staff.

Afzal has worked as part of the senior leadership team in developing and planning services to meet the needs of children and families. Afzal has also led the planning and implementation of effective services for all children with complex needs, including disabled children, looked-after children, and children in need and in need of protection, as well as developing the workforce and creating a learning environment for staff.
